The District has continually engaged with stakeholders regarding the impact of COVID-19 on student learning, and has sought community input in a variety of settings including:

- Parent Survey--April 29, 2021
- Student input session with School Site Council--May 2021
- District staff meeting--April 21, 2021
- Negotiations with employee representatives, the Buellton Education Association (BEA)--Spring 2021, continuing August 2021, September 16-17, 2021

In addition, the district held a meeting specifically for response and input on the draft of this plan virtually via Zoom on October 5, 2021 prior to finalizing plans for expenditures related to this program.

At every step, community input has influenced development of this plan. Resources have been committed to coordinate the provision of services utilizing one-time funds from several sources to make the most of each dollar in serving student learning needs effectively. Specific strategies in response to the identified learning needs of students were developed with needs identified in Parent Surveys and Town Hall sessions. The prioritization of social and emotional learning needs and the mental health of students emerged directly from student and staff input and are reflected throughout this plan. Specific revisions suggested in the meeting on October 5, 2021 resulted in changes and the further refinement of the plan to address specific student needs including increased social-emotional support, specific extended learning opportunities, and augmented use of assessment to target academic intervention.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
